With respect to the subject mentioned above the following are the terms and conditions for submitting tender.

1. Any person/contractor/registered travel agents may apply. They have to submit all documents as per format of Technical Bid.
2. The vehicle should be in good condition and it should not be more than three year old.
3. Tenderers should submit PAN No.
4. The person/contractor/travel agent should submit his identity proof.
5. Tenderers are required to deposit Rs. 10000/- (Ten Thousand Rupees) only as Demand Draft in favour of Principal, Bakhtiyarpur College of Engineering, Patliputra, Patna payable at Patna with tender document as security money, otherwise the tender will be summarily rejected.
6. The tender will be opened on 12.10.2019 at 11:00 AM in the office of the undersigned.
7. The undersigned reserves the right to rejects any or all the tenders without assigning any reason thereof.
8. The comparatively new vehicles and of higher model will be given priority.
9. The vehicle supplied should be preferably in the name of tenderer.
10. The contact will be kept valid for a period of two years which can be extended on mutual consent basis on the same terms and conditions for further one year (max two times)



11. Vehicles deployed should be good running condition and should have commercial registration, current comprehensive insurance and road tax coverage, permit, fitness and driving license of driver etc.
12. Contractor should keep the vehicles in neat, clean and good running conditions with sheet cloth covers, which should be replaced with another set of washed covers once in a week. The contractor should carry out the periodical maintenance of the vehicles supplied and insure them always in good condition.
13. All payment towards lubricants, repairs, insurance, any taxes etc and any other expenditure related to vehicles is the contractor's sole responsibility, all payment to the driver towards their salary, overtime etc is also the contractor's responsibility.
14. Income Tax/Surcharges will be recovered at source as per IT rules in force from time to time and nay other taxes like service tax which is applicable be paid by vendor.
15. Payment will be made on submission of bills.
16. The contractor can be terminated by giving one months notice in writing by either party. In case of breach of terms and condition, BCE, Bakhtiyarpur, reserves the right to terminate the contract without giving any notice.
17. In case of accident etc. BCE, Bakhtiyarpur has no responsibility whatsoever towards, police/RTA, court of law, injured parties, damages to the vehicle or property or any claim made for the loss etc. All these are entirely the contractors responsibility.
18. Any deviation/Violation or breach of the said terms and condition will be viewed seriously, and the contractor will be terminated without prior notice.
