- 1. Any person/vehicle owner/registered travel agents may apply. They have to submit all documents as per format of Technical Bid and financial Bid.
- 2. The vehicle should be in good condition. Comparatively new vehicles and of higher model will be given priority.
- 3. The tender fee of Rs. <u>1000/- (One Thousand Rupees only)</u> and E.M.D. of Rs. <u>5,000/- (Five Thousand Rupees only)</u> -only in the shape of demand draft separately on any nationalized bank in favor of Principal, Bakhtiyarpur College of Engineering, Bakhtiyarpur payable at Bakhtiyarpur should accompany tender paper.
